(Note 2) "Almost the entire process recorded" refers to cases where voice and video recording was not carried out initially at the referral stage due to the fact that it was not known that the suspect had communication problems due to intellectual disorders, but after it was revealed that the suspect had communication problems due to intellectual disorders, all subsequent interrogations were recorded.
